- Agency of the Dutch government
- Programme implementation:
 - Technology & Innovation
 - Energy & Environment
 - International Co-operation
- 760 employees
- Yearly Budget: EUR 1 billion





Costs to comply are high

- 6 percent reduction = 40 Mtonne / year
- domestic costs EUR 10 130 / tonne
- mechanisms: < EUR 10 / tonne
 - Joint Implementation
 - Clean Development Mechanism
 - International Emission Trade
- Start a JI and CDM programme






Why is CDM and JI of interest to Investors?

- Higher Return on Investment
 - Adding Value to CO₂ Reduction
 - Extra Client of the Investment (No Risk Taking)

Higher Return on Investment (2)

Based on Market Price!!

Expectation:

Price between EUR 2 - 6

- 5 20 % for Energy Production
- 50 100 % for Landfill Gas Extraction





JI/CDM - why participate?

- Investors
 - higher return on investment
- Host country governments
 - attract foreign investment
 - decrease pollution
- Government of The Netherlands
 - attractively priced carbon credits


- Renewable Energy

Criteria

- selection criteria:
 - exclusion criteria
 - financial and economic standing
 - technical capacity
- contract award criteria
 - price per carbon credit (ton CO2e)
 - feasibility of the project





Wind farm Poland

- 60 MW windfarm
- 30 turbines 2 MW
- co-operation Nuon (NL) and EPA (PL)
- 583,500 ton CO₂e reduced
- carbon contract EUR 5.25 million





Planning for this year (2002)

- Tender CDM (Asia, Africa and Latin America)
 - 1 or 2 more tenders expected
- Tender JI (Central and Eastern Europe)
 - 2 more tenders
